



We are the Nursing and Midwifery Council (NMC).



Our job is to help nurses, midwives and nursing associates do the best job possible.



We want to make sure nurses, midwives and nursing associates have the skills and knowledge they need to do their jobs well.



This will mean they can give everyone the best care possible, and keep people safe and healthy.

About this survey



When someone is learning to be a nurse, midwife or nursing associate in this country, they will do a training course that we have approved.



We only approve courses that meet the right standards - that means the quality of the course is very good, including:

• What the students will learn and who will teach them.





- Who is allowed to take part in the course.
- Where and how the course is taught.

Before Brexit, when the UK left the European Union, our standards had to follow the same rules as all other countries in the European Union.

But now the standards can follow our own rules here in the UK.

We would like to improve the standards for the UK by making some changes.

There are 4 areas we are suggesting changes to:

- 1. Choosing who can take part in a course.
- 2. The knowledge, skills and experience people will get during a course.













3. The places where courses are taught.

4. Simulation - this is training that is set up to be like a real-life situation.



We have worked together with other organisations and health professionals to think about the changes.



Before we make a final decision about changing our standards, we want to know what you think about our ideas.

1. Choosing who can take part in a course

At the moment, our standards say that you need to have been in education for at least 12 years before you can take part in a nursing or midwifery course.



But this may not be fair to everyone. Some people don't get the same chance to go to school as other people when they are growing up.



We want to remove this from our standards so that we are being fair to everyone.




We also want to add in a new part to our standards, for anyone under the age of 18 who applies to take part in a course.



We want our standards to say there must be rules in place that make sure anyone under 18 is supported to be safe from harm.




Question 1: Do you agree or disagree that we should stop saying people have to have been in education for at least 12 years before they can take part in a course?






Question 2: Do you agree or disagree that we should make sure there are rules in place to support anyone under 18 who takes part in a course?


2. The knowledge, skills and experience people will get during a course

At the moment, our standards say what knowledge, skills and experience people should get during a course. But it still mentions the rules for all countries in the European Union.

We want to remove mention of the European rules from our standards.

But we are suggesting keeping the information from the European rules about what experience people should get when they are training to become a midwife, including:

- The number of women they should help to have a baby.
- Dealing with different types of problems that women have during pregnancy and having a baby.



So we want to remove mention of the European rules on where nurses should go to get experience training in different organisations.


We think it is important for midwives to get experience in different organisations.



4. Simulation

Simulation is when something is set up to be like a real-life situation.

For nurses, simulation could be things like practising to put a bandage on a plastic dummy instead of a real person. Or, doing some training on a computer instead of face-to-face.

At the moment, our standards follow the European rules that say nurses must do the **practice learning** part of their training with other people.

Practice learning is the part of a training course that nurses do in a health setting, like a hospital, with real people who need care.

Other parts of the course are done in a classroom, with a teacher and other students.












We think nurses should be allowed to do some of their training using simulation. So we are suggesting changing our standards to allow nurses to do part of their training using simulation instead of with other people.



But we still want midwives to do all of their practice learning with real people instead of using simulation.


