Decision and reasons on interim order

The panel decided to confirm the current interim conditions of practice order.

The panel was of the view that the public would remain suitably protected by the continuation of the following conditions:

For the purposes of these conditions, 'employment' and 'work' mean any paid or unpaid post in a nursing, midwifery or nursing associate role. Also, 'course of study' and 'course' mean any course of educational study connected to nursing, midwifery or nursing associates.

- You must limit your nursing practice to Nottinghamshire Healthcare NHS Foundation Trust.

- 4. You must be directly supervised when carrying out the management or administration of any controlled drugs and the setting up and administration of medication through the use of syringe drivers until you have completed training in these areas and you are deemed competent to do so by a registered nurse of band 6 or above. You must send evidence of your competence in these areas to your NMC case officer within 14 days of completion of your competency assessment.
- 5. You must meet with your line manager, mentor or supervisor fortnightly to discuss the standard of your practice in relation to:
 - [PRIVATE]
 - Medications management and administration;
 - Effective communication;
 - Documentation and record keeping;
 - Escalating concerns;

- · Your clinical caseload; and
- Your progress with your training and achieving your competencies.
- 6. You must provide a report from your line manager, mentor or supervisor 7 days before any review of this order. This report should focus on the standard of your practice in relation to:
 - [PRIVATE]
 - Medications management and administration;
 - Effective communication;
 - Documentation and record keeping;
 - Escalating concerns;
 - · Your clinical caseload; and
 - Your progress with your training and achieving your competencies.
- 7. You must keep the NMC informed about anywhere you are studying by:
 - a) Telling your case officer within seven days of accepting any course of study.
 - b) Giving your case officer the name and contact details of the organisation offering that course of study.
- 8. You must immediately give a copy of these conditions to:
 - a) Nottinghamshire Healthcare NHS Foundation Trust
 - b) Any establishment you apply to (at the time of application), or with which you are already enrolled, for a course of study.
- 9. You must tell your case officer, within seven days of your becoming aware of:
 - a) Any clinical incident you are involved in.
 - b) Any investigation started against you.
 - c) Any disciplinary proceedings taken against you.

10. You must allow your case officer to share, as necessary, details about your performance, your compliance with and / or progress under these conditions with:

- a) Nottinghamshire Healthcare NHS Foundation Trust.
- b) Any educational establishment.
- c) Any other person(s) involved in your retraining and/or supervision required by these conditions.

The panel decided to confirm this interim conditions of practice order and it will run for the remainder of the current interim order.

Unless your case has already been concluded, this interim order must be reviewed before the end of the next six months and every six months thereafter. Additionally, you or the NMC may ask for the interim order to be reviewed if any new evidence becomes available that may be relevant to the interim order.

At any review, the reviewing panel may revoke the interim order or any condition of it, it may confirm the interim conditions of practice order, or vary any condition of it, or it may replace the interim conditions of practice order with an interim suspension order.

In certain circumstances, it may be possible for the interim conditions of practice order to be reviewed by a reviewing panel at an administrative meeting. Your case officer will write to you about this in due course.

The NMC Case Examiners are yet to decide whether there is a case to answer in relation to the allegations made against you. The NMC will write to you when the case is ready for the next stage of the fitness to practise process.

This will be confirmed to you in writing.
