Decision and reasons on interim order

The panel decided to vary the current interim conditions of practice order.

The panel has determined that the following conditions are proportionate and appropriate:

‘For the purposes of these conditions, ‘employment’ and ‘work’ mean any paid or unpaid post in a nursing, midwifery or nursing associate role. Also, ‘course of study’ and ‘course’ mean any course of educational study connected to nursing, midwifery or nursing associates.

3. You must limit your practice to working for one substantive employer. This must not be an agency or bank agreement.
4. You must not be the nurse in charge of any shift.
5. You must not have access to and/or be involved in the administration and management of medication unless directly supervised by another registered nurse.
6. You must meet with your line manager, supervisor or mentor fortnightly to discuss:
 - a. [PRIVATE]
 - b. Your professional conduct
7. You must immediately give a copy of these conditions to:
 - a) Any organisation or person you work for.
 - b) Any employers you apply to for work (at the time of application).

- c) Any establishment you apply to (at the time of application),
or with which you are already enrolled, for a course of study.
- 8. You must send a report from your line manager or supervisor to
the NMC prior to any review meeting or hearing outlining:
 - a. [PRIVATE]
 - b. Your professional conduct

- 16. You must keep the NMC informed about anywhere you are
working by:
 - a) Telling your case officer within seven days of accepting or
leaving any employment.
 - b) Giving your case officer your employer's contact details.
- 17. You must keep the NMC informed about anywhere you are
studying by:
 - a) Telling your case officer within seven days of accepting any
course of study.
 - b) Giving your case officer the name and contact details of the
organisation offering that course of study.

18. You must tell your case officer, within seven days of your becoming aware of:

- a) Any clinical incident you are involved in.
- b) Any investigation started against you.
- c) Any disciplinary proceedings taken against you.

19. You must allow your case officer to share, as necessary, details about your performance, your compliance with and / or progress under these conditions with:

- a) Any current or future employer.
- b) Any educational establishment.
- c) Any other person(s) involved in your retraining and/or supervision required by these conditions.'

Unless Mrs McCann's case has already been concluded, this interim order must be reviewed before the end of the next six months and every six months thereafter. Additionally, Mrs McCann or the Nursing and Midwifery Council (NMC) may ask for the interim order to be reviewed if any new evidence becomes available that may be relevant to the interim order.

At any review a panel may revoke the interim order or any condition of it, it may confirm the interim order, or vary any condition of it, or it may replace the interim conditions of practice order with an interim suspension order.

The NMC Case Examiners are yet to decide whether there is a case to answer in relation to the allegations made against Ms McCann. The NMC will write to Mrs McCann when the case is ready for the next stage of the fitness to practise process.

This will be confirmed to Mrs McCann in writing.

That concludes this determination.
