Section two

Summary of review and findings

The University of West London (UWL) is a Nursing and Midwifery Council (NMC) approved education institution (AEI). The original pre-registration nursing programme was approved by the NMC on 2 September 2019. The routes within the approved programme include, a full-time three-year Bachelor of Nursing (Honours) (BNursing (Hons)) nursing (adult, mental health, children and learning disabilities), a two-year full-time postgraduate diploma (PG dip) in adult, mental health and learning disabilities nursing, a full-time four-year dual award integrated master's in nursing (MSci) (adult and mental health; mental health and children; mental health and learning disability) and a three-year full-time registered nurse degree apprenticeship (NDA) BNursing (Hons) nursing (adult, mental health, children and learning disabilities).

The approved pre-registration nursing programme was modified on 11 November 2021 to include a full-time two-year, pre-registration nursing MSc blended learning nursing route in adult or learning disabilities.

This proposal is to modify the approved PG dip nursing route to deliver NDA PG dip nursing adult, mental health and learning disabilities. The new route will be delivered with set theory and placement blocks and with employer weeks that are fixed. Annual leave is taken during employer weeks.

The proposed start date for the new route is 25 September 2023.

This major modification is undertaken face to face.

Documentary evidence and discussion with the programme development team, senior managers and employers and practice placement partners (PLPs) confirms support for the proposed NDA PG dip nursing route at level seven. The programme modification is in response to employer requests to include an apprenticeship route via a PG dip route. PLPs tell us the NDA students will contribute to future workforce planning. UWL tells us numbers of NDA students are expected to be small. NDA students and direct entry students will be taught together.

Documentary evidence and the modification visit confirm the NDA PG dip nursing route has been negotiated and developed with senior managers of eight participating healthcare organisations. The following organisations are supporting the NDA PG dip nursing route: Frimley Health NHS Foundation Trust (FHFT), Surrey and Borders Partnership NHS Foundation Trust (SBPFT), Ashford and St Peter's Hospitals NHS Foundation Trust (ASPHFT), Berkshire Healthcare NHS





Foundation Trust (BHFT), Royal Berkshire NHS Foundation Trust (RBFT), Chelsea and Westminster Hospitals NHS Foundation Trust (CWHFT), West London NHS Trust (WLFT) and Central and North West London NHS Foundation Trust (CNWLFT). These employer partners (EPs) will employ and provide practice learning placements for the students studying on the proposed route. UWL and EPs confirm that reciprocal arrangements are in place between EPs to ensure opportunity for students to experience all fields of nursing and a broad range of practice placement experiences.

Programme documentation and the modification visit confirm evidence of effective partnership working between UWL and PLPs. There is assurance that governance arrangements are in place to ensure the quality and safety of practice learning. Documentary evidence confirms UWL have effective collaborative arrangements and effective lines of communication with all eight EPs to ensure effective response to system regulator concerns and all internal and external quality concerns.

The Standards framework for nursing and midwifery education (SFNME) (NMC, 2018), Standards for student supervision and assessment (SSSA) (NMC, 2018 updated 2023), Standards for pre-registration nursing programmes (SPRN) (NMC, 2018 updated 2023) and Future nurse: Standards of proficiency for registered nurses (FN:SPRN) (NMC, 2018) are mapped against the original programme approved in September 2019. Programme documentation confirms that the programme content and assessment strategy are unchanged from the PG dip nursing (adult, mental health and learning disabilities) route approved on 2 September 2019. An adaptation is made to the duration of the programme. Students on the NDA PG dip route will be employed for 37.5 hours per week. The programme is therefore extended to incorporate an extra three weeks plus up to one month to complete the end point assessment (EPA) to ensure 2300 practice hours are completed.

This route responds to challenges experienced in the adult, mental health and learning disability nursing workforce and enables recruitment from a further pool of students providing graduate employment. The numbers recruited to the programme are expected to be small. Documentary evidence confirms there are processes in place to ensure sufficient resources to deliver the programme.

Programme documentation and the modification visit confirm that students on the NDA PG dip nursing route will have access to the same theory and practice learning support as students on the approved PG dip nursing route. UWL tell us that in addition, students on the NDA PG dip nursing route will have 12 weekly tripartite progress review meetings and will complete the EPA at the end of the programme.

Programme documentation provides equality, diversity and inclusion (EDI) data and demonstrates there are currently no attainment gaps within the student





population. There's an infrastructure within the college and wider university to monitor achievement, progression and awarding gaps. This is frequently reviewed, and actions taken when necessary. The recruitment, teaching and learning and assessment strategies are all designed to ensure a socially and culturally inclusive experience for students.

The SFNME are met at programme level.

The SSSA are mapped in the programme and are met at programme level.

Findings against the standard and requirements

Provide an <u>evaluative summary</u> about the effectiveness of the partnerships between the AEI and their practice learning partners, people who use services, students and any other stakeholders.

There's documentary evidence that the UWL demonstrates effective partnership working with EPs. Programme documentation and evidence from the modification visit confirms effective partnership working between UWL and their PLPs, EPs, people who use services and carers (PUSCs) and students. Stakeholders tell us and documentary minutes confirm involvement in the coproduction of the NDA PG dip nursing route. Documentation and evidence at the modification visit confirms that practice placement agreements, apprentice commitment statements and satisfactory practice placement audits ensure the quality of the practice placement experiences. The agreements commit the university, PLPs and EPs to the provision of safe and supportive learning environments for students on the NDA PG dip route.

The programme team and the EPs tell us the recruitment and selection process of students is undertaken in partnership. The employer submits potential candidates' details to UWL via upload of an Excel spreadsheet, to a secure SharePoint link. UWL then upload the candidate details to an online apprenticeship platform used for application and enrolment. Employers are required to supply a line manager character reference. Documentary evidence and the modification visit confirm that UWL admissions screen each candidate to check they meet both the academic and eligibility criteria for the NDA PG dip route. Candidates are then invited to an individual values-based interview jointly facilitated by an academic, employer representative and PUSC representation. The programme team and employers tell us EPs adhere to their internal organisational processes in relation to undertaking enhanced Disclosure and Barring Service (DBS) and occupational health (OH) checks. These processes





have been signed off by the respective NHS trust boards of the employer organisations. Where an issue is identified on an enhanced DBS report/OH report the employer will undertake due diligence, in line with their processes. They will discuss any concerns with UWL.

Employers are required to confirm that satisfactory enhanced DBS and OH checks are in place for a course leading to eligibility to register with the NMC via Aptem, an apprenticeship online application and enrolment system. Documentation and the modification visit confirm the employers have responsibility for mandatory training of the students on the NDA PG dip route. The module leader for the practice modules will request a screenshot of the EP's training monitoring tool/or request evidence of training via email confirmation and evidence of certificates. This check will be carried out before the first placement and then again in year two and at the end of the programme. This information is collated on a spreadsheet shared with the course leader and personal tutors. Should an occasion arise where an employer is not able to provide the mandatory training (in time for a placement to commence), the student will access the training being delivered for the self-funding students in the cohort.

Documentary evidence is provided to support the university's commitment to service user involvement in healthcare education. Documentation and PUSCs tell us they undertake EDI training before recruitment activities and are updated yearly. PUSCs tell us they are consulted about and contribute to the design and the delivery of the NDA PG dip route. They tell us they are supported, and they feel valued when they participate in UWL meetings and activities. PUSCs tell us they are actively and regularly involved in teaching activities, including simulation, and in assessment activities for objective structured clinical assessments.

There's documentary evidence and confirmation from students at the modification visit they have been consulted and have contributed to the design and development of the new route. Students on current apprenticeship routes tell us that processes are in place for them to give feedback on their theory and practice learning and that they have a student representative system. They tell us they are supported by both employers and by UWL to ensure supernumerary status and experience a breadth of practice placement experiences. Documentary evidence and students tell us they have opportunities to learn from a range of people in practice learning environments, including PUSCs and through inter-professional learning.

Senior nurses and practice education leads tell us there are effective processes in place to respond to the needs of students, practice supervisors and practice assessors.





The programme team tell us there are systems and processes in place to ensure academic assessors are supported within their role to support students undertaking practice learning opportunities. The programme team, senior nurses and practice education staff tell us there are suitable systems, processes and resources in place to ensure safe and effective coordination of learning within practice learning environments.

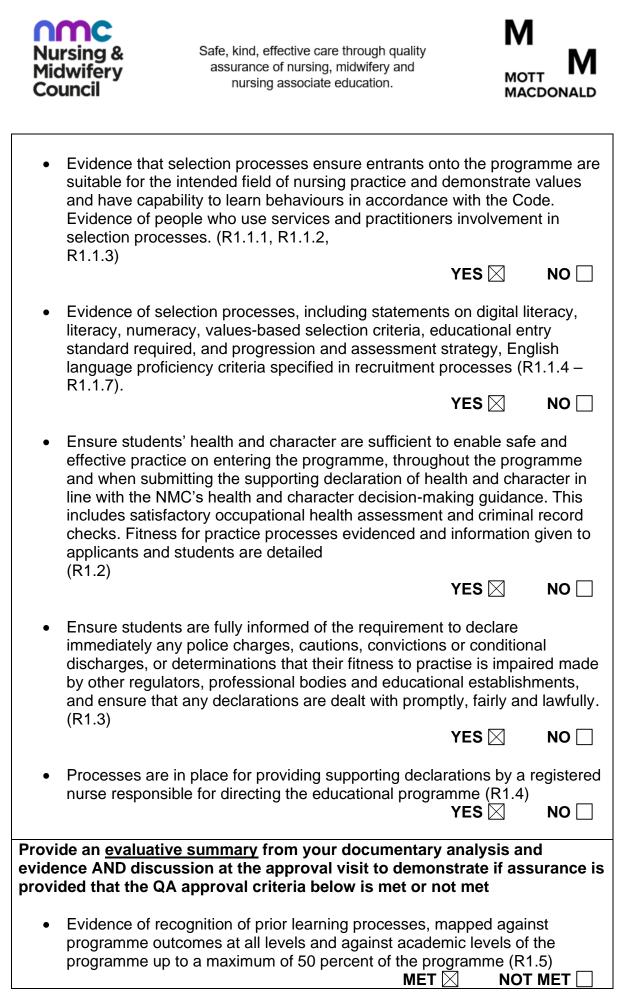
