The **Nursing and Midwifery Council (NMC)** wrote this paper.



We help make sure people using services and patients get good, safe care.



This paper is about what we want to do from 2020 – 2025.



We have been listening to what people think about health and social care services.

And the care they have had.

#### What we do



We **regulate** nurses and midwives in the UK and **nursing associates** in England.

We do this by:



•saying what they must learn



 putting them on our register when they finish training for their job



 make sure people on the register keep to our Code. The Code says how they must behave and give safe care



 we support the people on our register to keep learning while they work. And keep meeting the right standards



•we think professionals should learn from their mistakes but we look into things if people get poor or unsafe care.

## Some of the problems in health and social care

#### Not enough staff



There are not enough nurses, midwives or **nursing associates** across the UK.



There are not enough people working in learning disability services.



There are not enough people working in mental health services.





Many people are living longer. And they can have lots of health needs.



Their care needs are more complicated than they used to be.



So staff need lots of skills to deal with this.



And people need to learn about their health issues. So they can help themselves more.

#### **New medicines**



We are learning more and more about better medicines and things like our **genes**.



We use equipment more and more to help with our health.



This is changing the way care is given.

#### Different ways of caring



Health and social care is changing. For example, more people are being cared for at home.



Sometimes people work with a lot of different health and social care staff.



We need to make sure we work well together.

#### **Careers**



People need choices to train to become nurses, **midwives** or **nursing associates** in the way that is right for them.



For example, some nurses are carers so cannot train full-time.

#### Making sure people are treated fairly



Things are not always fair and equal for everyone in health and social care.



We want to do what we can to help make things more fair and equal.



#### The environment

This is about the world we live in.



People are more worried about the **environment** than before.



They are thinking more about where things come from, if they are made of plastic and if they damage the **environment**.

#### Changing how care is managed



There have been a lot of changes in the ways nurses, **midwives** and **nursing associates** work.



For example, they need to work as part of a team more.



These changes will change the way we check people on our **register**.

## What we have done in the last 5 years

Here are some examples of what we have done:



•Checked everyone on our **register** is still working well.



•Checked they are following the **Code**.



•And checked they are still learning.



•Opened a new part of the register for **nursing associates**.



 Made new standards nurses and midwives need to work to.



 Helped nurses and midwives know what to do when they have been off work for a while.



•Changed the rules for checking people are working properly.



•Changed how people are **registered** when they train in other countries.

#### Code

A set of rules that people in a job or organisation must keep to.

#### Genes

Genes are the units that make up a person.

#### **Environment**

This is everything around us. Things like nature and the air we breathe.

#### **Midwives**

People who are trained to give women support, care and advice during pregnancy, labour and after the baby is born.

#### **Nursing associates**

This is a new role in England. Nursing associates are trained to work with nurses to support and care for patients and service users.

#### Register

A list of people who have the right training and meet the rules. For example, people who can give good, safe care.

#### Regulate

Make sure people keep to rules and do things safely.

#### **Standard**

A list we use to judge how good something is or say how good it should be.
