Our education change programme: a reminder

Covers two specific sets of standards:

- Standards of proficiency
 Describe what people need to know and be able to do
- 2. Education and training standards (including programme standards)

These are for universities and practice partners

Since 2016, we've renewed and updated standards for:

- Registered nurses
- Midwives
- Nursing associates in England
- Prescribing
- Return to practice





Drivers for our ambitious new SCPHN standards

- In today's health and care services, the roles of SCPHNs are changing and expanding
- SCPHNs require higher levels of autonomy, specialist knowledge and skill in order to achieve their full potential and to lead and contribute to the delivery of public health services
- SCPHN professionals are in the frontline of public health
- They are culturally competent, autonomous practitioners who are committed to improving people's health and wellbeing
- They understand the wider determinants of health and seek to address health inequalities across the diverse communities and populations they serve.

The relationship between SCPHN core and field specific standards



What happens now

- New standards published in July 2022 came into effect on 1 September 2022
- Post-registration students on existing programmes can complete the programme they started
- Development of new curricula that meets the new standards this should involve universities, practice placement partners, SCPHN students, SCPHN professionals and users of service/members of the public
- They should discuss and agree routes within the SCPHN curriculum/programme to be developed - SCPHN HV, SCPHN SN, SCPHN OHN and/or SCPHN PHN NB: a new Trailblazer group in England is developing a new apprenticeship standard that meets the new NMC SCPHN standards



What happens now: Prescribing considerations

Transition and approval of new programmes



Approval of new programmes

- Seek formal approval of new SCPHN programmes in line with the NMC QA framework
- QA and approval of new programmes will be in line with our gateway approach. This means that:
 - Gateway 2 will focus on the standards to support supervision and assessment
 - Gateway 3 will focus on proficiency standards, post-registration programme standards and their relationship with Parts 1 (education framework) and 2 (SSSA)
 - Gateway 4 is the approval event (in person/hybrid)
- All SCPHN programmes must be approved in line with new standards by 31 August 2024
- No students will be able to commence a programme approved against the 2004 SCPHN standards after 31 August 2024

Supporting implementation and bridge to the future



Supporting implementation

We will:

- Run UK wide engagement events
- Participate in other UK wide external events and meetings
- Facilitate introductions and conversations e.g. pan-assessment initiatives
- Develop supporting information for SSSA and for SCPHN proficiency standards
- Appoint post-registration adviser roles

A bridge to the future

 We have committed to exploring whether the regulation of advanced practice is needed. These new post registration standards will form a bridge to the work we will go onto do later in 2022
